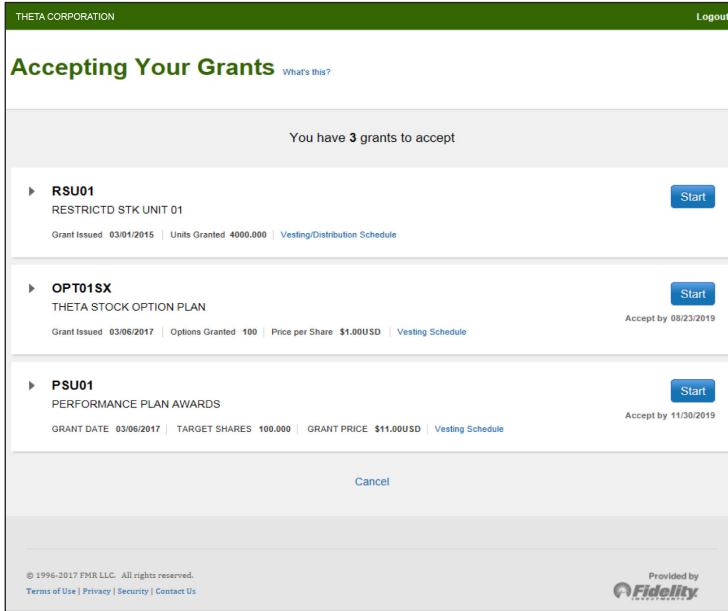

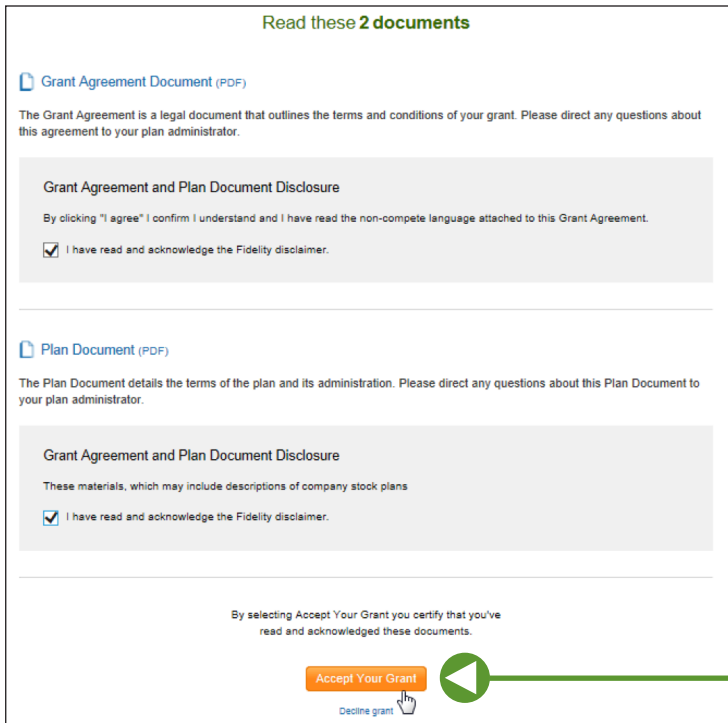
3. On the Stock Plans page, scroll down to Your Grants by plan and click *Begin Acceptance*.

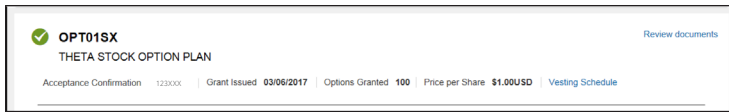
4. On the Accepting Your Grants page, you will see all the grants awaiting acceptance. For a specific grant, click the *Start* button to review each grant document.
